Introduction

Fairtrade NAPP (Network of Asia and Pacific Producers) is a crucial network that empowers Fairtrade-certified farmers and workers across the Asia Pacific region. These dedicated producers, who own 50% of the Fairtrade system, advocate for fair wages, sustainable practices, and ethical trade. With 300 pilots supporting over 2 lakhs farmer, NAPP contributes to a more equitable and sustainable world by championing responsible production and consumption of a diverse array of Fairtrade products.

The Accrue App is a created by the Fairtrade NAPP. It empowers Fairtrade-certified farmers and workers across the Asia Pacific region by providing them with a user-friendly platform for data management. The app allows users to conduct surveys, monitor progress, and perform geofencing tasks. Now, our goal is to extend its reach by developing an iOS version.

Project Scope

Designing and developing an iOS version of the Accrue App while ensuring consistency with the existing Android app.

- Provide various types of fields such as Area on Map, Distance on Map, location, image Geotag, etc,.
- Track real time data with Live Tracking
- Data presentation in Matrix, Scaling, Rating and Conditional format.
- Registration on mobile App through phone number.
- Efficient interface for iOS users.
- Collection of data in groups (same question for different user).
- Other features Monitoring, Barcode, Signature.

- A fully functional iOS app with the same core features as the Android version.
- Weekly Status reports on the performance of the Mobile App
- Clear instructions for app usage.
- Comprehensive testing reports to verify app functionality.
- Source Code Well-documented and organized codebase.
